REQUIREMENTS AND INSTRUCTIONS

REQUIREMENTS

AGE

- JR. SPIRIT participants shall be between 8 and 10 years of age during the week of Fiesta (Sunday, July 30th through Sunday, August 6th 2017).
- SPIRIT participants shall be between 16 and 20 years of age during the week of Fiesta (Sunday, July 30th through Sunday, August 6th 2017).

ELIGIBILITY

- The Pre-Audition is an "OPEN CALL" to all dancers. Must be a resident and reside in Santa Barbara County
- The goal is to select the individual who best embodies the "SPIRIT" of Santa Barbara's Fiesta.
- The selection from the Pre-Audition participants for the Audition Finals will be based on a combination of factors: dance talent, dance history and experience, poise and communication skills, community service and involvement in the greater Santa Barbara Community, and a positive working relationship and history with the Old Spanish Days organization and events.

PRE-AUDITION INSTRUCTIONS

The pre-audition will be held Saturday, January 7, 2017 at La Cumbre Jr. High School located at 2255 Modoc Rd., Santa Barbara, Ca. The auditions will be open for ALL participants, who are residents and reside in the County of Santa Barbara, from 9:00 am until 12:00 pm. You may come at any time during the three hour period. This is a first come first serve Pre-Audition so arrive early.

- Provide a copy of participant's birth certificate (certificates on file with Old Spanish Days will NOT satisfy; you
 must provide a copy WITH the completed application)
- Provide signed Participant Guidelines form.
- Provide signed Release and Hold Harmless Forms.
- Provide \$25.00 registration fee (check payable to: Old Spanish Days).
- Provide two CD copies of the music that you wish to dance to at the Pre-Audition (music cannot be longer than one minute and thirty seconds in length).

Scores will not be distributed to participants of the Pre-Audition.

•	Act responsibly with pride representing Old Spanish Days (OSD) and participating in an OSD event.				
•	Follow all OSD event rules and requirements and obey all terms and conditions set forth by the event committee and/or OSD.				
•	Treat every participant and OSD representative with respect by refraining from disparaging comments, accusations, and unfavorable implications or information about another participant or OSD representative.				
•	Ensure your attendance conforms to the requirements of your event or activity (i.e. arrive on time).				
•	Follow the dress code and personal appearance standards for the event or activity, (i.e. wear the costume specific to each event). Personal appearance standards include, but are not limited to, no visible body piercing (excluding earrings) or tattoos, hairstyles that appropriate to the activity or event, and no jewelry that is out of character with the required costume or accessories. (Note Spirit Participants: Batas de Cola are not allowed at Fiesta Pequeña and will not be accepted). The design of your dress is due by the first Pequena rehearsal.				
•	Acceptable behavior. Since we are in the public eye, we must always be mindful of our actions and ensure they are appropriate to the situation. That means no substance abuse, fighting, swearing, or displays of public affection or public intoxication. Inappropriate publicity of photos or comments on Social Media sites (e.g., Facebook, Instagram, or Twitter) will be grounds for removal as a participant in current and/or future Auditions or other OSD venues and events.
